Environmentally Friendly Procurement Policy of Kamphaeng Phet Rajabhat University

Kamphaeng Phet Rajabhat University has put into practice the Green Office Project for the Central Administration Building (Building 14) to move towards a sustainable green university. To align procurement practices with university policy, a committee responsible for environmentally friendly procurement has been appointed. This committee's role is to ensure that purchasing practices support the university's green management goals, encouraging university personnel to select products and services that are environmentally responsible. By choosing eco-friendly goods and services, university members can help reduce negative impact on the environment, preserve natural resources, and contribute to mitigating climate change. The Green Procurement Committee has studied the criteria and procedures regarding environmentally friendly goods and services and has issued the policy regarding procurement as follows.

1. Kamphaeng Phet Rajabhat University will carry out procurement and develop an environmentally friendly procurement system. The Procurement Committee is required to improve and develop environmentally friendly procurement procedures in accordance with the Procurement and Procurement Act, Public Procurement Management B.E. 2560 (2017), Regulation of the Ministry of Finance on Procurement, Procurement Management Government Sector B.E. 2560 (2017) and, Ministerial Regulation.

2. Kamphaeng Phet Rajabhat University will carry out procurement and improve the efficiency of accounting data. The Procurement Committee is required to operate continuously and in accordance with operating costs and good operating practices. This is in line with the Department of Pollution Control and the Public Procurement and Procurement Management Act, B.E. 2560 (2017), and the Regulation of the Ministry of Finance on Public Procurement and Procurement Management. B.E. 2017 and Ministerial Regulations as well as relevant government policies 2017 and Ministerial Regulations, including relevant government policies.

3. Kamphaeng Phet Rajabhat University by the Environmentally Friendly Procurement Committee will determine the plan and targets for environmentally friendly procurement of the General Administration, The Office of the President and the operating agencies at the Integrated and Administrative Building (Building 14) and the personnel of Kamphaeng Phet Rajabhat University. This is used in the selection of products and services in the implementation of various plans/projects.

4. Kamphaeng Phet Rajabhat University considers its contribution to reducing environmental impacts, conserving natural resources, reducing global warming, rapid climate change, and reducing global warming as the responsibility of all personnel. Everyone will cooperate in complying with the measures, guidelines, implementation, and good practices, set by the Green Procurement Committee, as well as monitor and report to the committee.

5. Kamphaeng Phet Rajabhat University will provide the necessary support, including human resources, budget, working time, training, clarification, understanding, and participation in the presentation of opinions to develop environmentally friendly procurement to be more efficient.

6. The executives and the Green Procurement Committee will review and improve the target policies and action plans for green procurement every 3 years.
